A roll call of board members was taken: Trustee Alexander, Trustee Haylett, Jr., Trustee Ross, Trustee Smith, Trustee Tylec, Trustee Virtuoso on zoom, and Student Trustee Williams were present. Chairperson Clark lead the assembly in the Pledge of Allegiance, along with a moment of silence for the men and women serving in the military, and for our first responders, police, firemen and other who risk their lives for our safety.

PUBLIC COMMENTS

There were no Public Comments.

CONSENT AGENDA

Chairperson Clark asked if Board members had any questions regarding the Consent Agenda items. It was moved by Trustee Tylec and seconded by Trustee Ross that the Board approve the minutes from the June 20, 2023 board meeting, Statement of Revenues and Expenditures (2), and Grant Activities. Motion carried unanimously.

INFORMATION ITEMS

Chairperson Clark asked Board members if there were any questions regarding the Information Items; Trustee Ross asked about personnel and filling open positions. Assistant Vice President Brown stated some changes to their recruitment strategies including placing openings on our daily system message, President Murabito states we will not compromise on the quality of our candidates just to fill the position. We do not close a search until the position is filled. The following items were received and filed: Grant Tracking Chart, Personnel Status Chart, Foundation Report, and Facilities Update. There were no further questions.

CHAIRPERSON'S REPORT

Chairperson Clark introduced our new student trustee Matteo D. Williams. He was sworn in at the Niagara County Courthouse yesterday. Student Trustee Williams provided some information on his background and his future plans. Welcome to Matteo.

Chairperson Clark stated the board meeting schedule is included in the materials; please note these important dates.

Chairperson Clark stated the board officers, committee appointments/representatives are also provided in the materials. Note there is still an open position for a trustee.

Chairperson Clark asked trustees to "Save the Date" of October 19, for the Scholarship Soiree. Director of Development Julie Berrigan provided a handout with the date, time and place of the event. The deadline for sponsorship is October 1. Chairperson Clark encouraged board members to support this event.

Chairperson Clark stated the annual NYCCT conference and awards banquet will be held on November 3-4 in Saratoga Springs. Those attending will be Trustees Clark, Ross and Tylec. Please let Barb Walck know if you are interested in attending.

Chairperson Clark stated on August 29, he will meet with SUNY Sr. Vice Chancellor Johanna Duncan Poitier via zoom to discuss and initiate the the presidential search process. Board members will be called upon to assist in this process.

PRESIDENT'S REPORT

President Murabito discussed the following:

- President Murabito stated over the past year, we have been celebrating the 60th anniversary of our college. Last Friday we hosted a concert "Nerds Gone Wild", as the final event. Special thank you to all the volunteers and employees who made this event so successful.
- President Murabito stated we are in the process of a campus rebranding. Assistant Vice President DeSimone stated a committee met with the rebranding company, and are very close to finalizing the final report. This has been a yearlong process and a presentation will be provided at the October board meeting.
- President Murabito discussed enrollment, and have targets on headcount, and credit hours; comparing from last year we are doing fairly well and look to make the target numbers. Housing has 259 deposits and are working on finalizing other applications.
- On July 11, the SUNY presidents met in Albany with Chancellor King; he is setting a tone for the colleges using his four pillars.

- On July 25, groundbreaking was celebrated for the Niagara County Law Enforcement Academy. We are looking forward to the grand opening sometime next year.
- The Veterans Memorial ribbon cutting will take place on November 9. More information will follow.
- On August 1, we hosted the Office for People With Developmental Disabilities Commissioner Kerri Neifeld, with Dr. Cindy Oberjosh taking the lead on this endeavor. This is a one-year grant to help train care workers.
- Yesterday, Dr. Sonya Smith, the state director for the SBDC was here on campus. She met with various people, and visited many of the small businesses in this area that have been opened with the help of our Niagara SBDC.
- President Murabito is part of the SUNY Cannabis Task Force group which met today headed by Chancellor King. Meetings will be held monthly with a final report due by the end of December.

Vice Chairperson Cafarella joined the meeting.
